under the Citi Global Medium Term Note Programme**

You may be aware that, as announced in its Newsletter 2023-N-005 on 3 February 2023 (found here: [Newsletter 2023-N-005 \(euroclear.com\)](https://www.euroclear.com)), Euroclear Bank has decided to fully withdraw the Russian Rouble (“RUB”) as a settlement currency. Consequently, Euroclear Bank is not accepting any money transfer instructions in RUB nor any incoming RUB payments, including in respect of income and redemption events for securities where RUB payments are required to be made.

This is in addition to the announcement by Clearstream Banking S.A. (“Clearstream”) on 4 May 2022 (ref A22018) that stated that RUB is no longer an eligible settlement currency for Clearstream.

We are sending you this notice because your securities belong to a Relevant Series of Securities and, as such, will be impacted by Euroclear Bank’s decision to withdraw RUB as a settlement currency. This means that we are prevented from being able to make any RUB denominated payments to Euroclear Bank or other international central securities depository in the ordinary way in order for them to make corresponding payments to you in respect of your securities. As a consequence, this means that you will not receive RUB payments on your securities in the normal way.

Given the highly unusual situation, please reach out to the contacts you ordinarily deal with in relation to your securities to discuss how to resolve this issue.

The Issuer reserves the right to publish further communications with proposals to address this situation.
